Terms and Conditions:

- a) Production (Sound System) to be provided by the 'juicy fruit band'
- b) Musicians to arrive one hour prior to performance for set up unless pre-arranged
If an earlier time is required, fees may apply
- c) Guest Refreshments and Meals to be provided for musicians during the "Breaks" or before the Performance, NOT after the event.
Arrangements should be made with the Caterers/Management of the Venue prior.
- d) Deposit of 15% is required prior to Performance (as confirmation)
- e) "Stage" area of 5 x 4 meters required for equipment and musicians with power points close to the stage
- f) Lighting is not supplied
- g) Each "Set" is 45 minutes in duration unless pre-arranged
- h) A Fee of \$300 per hour will be charged for over-time
- i) A band room or designated area/table must be provided for breaks.
Rest periods. (A table for 4 band members is required)
- j) Cash Payment or EFT to be made two weeks prior to the commencement of the Performance
- k) 50% of the Payment will be charged if the booking is cancelled.
- l) Parking is required or a fee of \$25 per vehicle will be charged

STANDARD BOOKING CONFIRMATION FOR CONTRACT OF SERVICES

Terms and conditions:

1. Any cancellation after this time shall be treated as a breach of contract and such a breach by the employer shall attract liability for the full fee.
2. Any special conditions attached shall not be formed in such a way as to breach the appropriate award conditions and / or employment law relevant to the contracting parties.
3. Responsibility for maintaining a safe working environment lies solely with the employer. Unsafe working conditions will represent a breach of this Agreement by the employer and attract liability for the full compensation. All other claims relating to safety and / or damages shall be determined by the appropriate legal tribunal.
4. All payment will be in the form of Cash payments or EFT before the performance unless otherwise pre-arranged.
5. The terms "employee/s" and employer refer to the contracting parties in the arrangement for provision of musical services. An agent may represent either the employer or the performer/s but is not a party to the contract. Where a theatrical employer or promoter is a signatory, obligations in Clause 4 may, by law, involve parties outside the contract. Anyone questioning such terms should consult their appropriate organization.
6. A Deposit of 15% of the agreed Fee shall be paid in advance prior to the proposed date/s as previously arranged.
7. The "Stage" or "Performing Area" should be undercover for safety reasons and close to at least two Power Outlets. This area should be a minimum of 5X4 Meters, depending on the size of the Band requested. The Musician/s will not perform in any outdoor situation where electrical equipment can be subjected to unpredictable weather conditions.
8. The Employer shall provide a Meal and Refreshments for the Musician/s during the course of the engagement, if the duration of the engagement exceeds 3 Hours. For engagements under 3 Hours, the Employer shall provide light Refreshments.
9. The Musician/s requires a minimum of One Hour prior to the commencement of the performance for set up and a sound check
